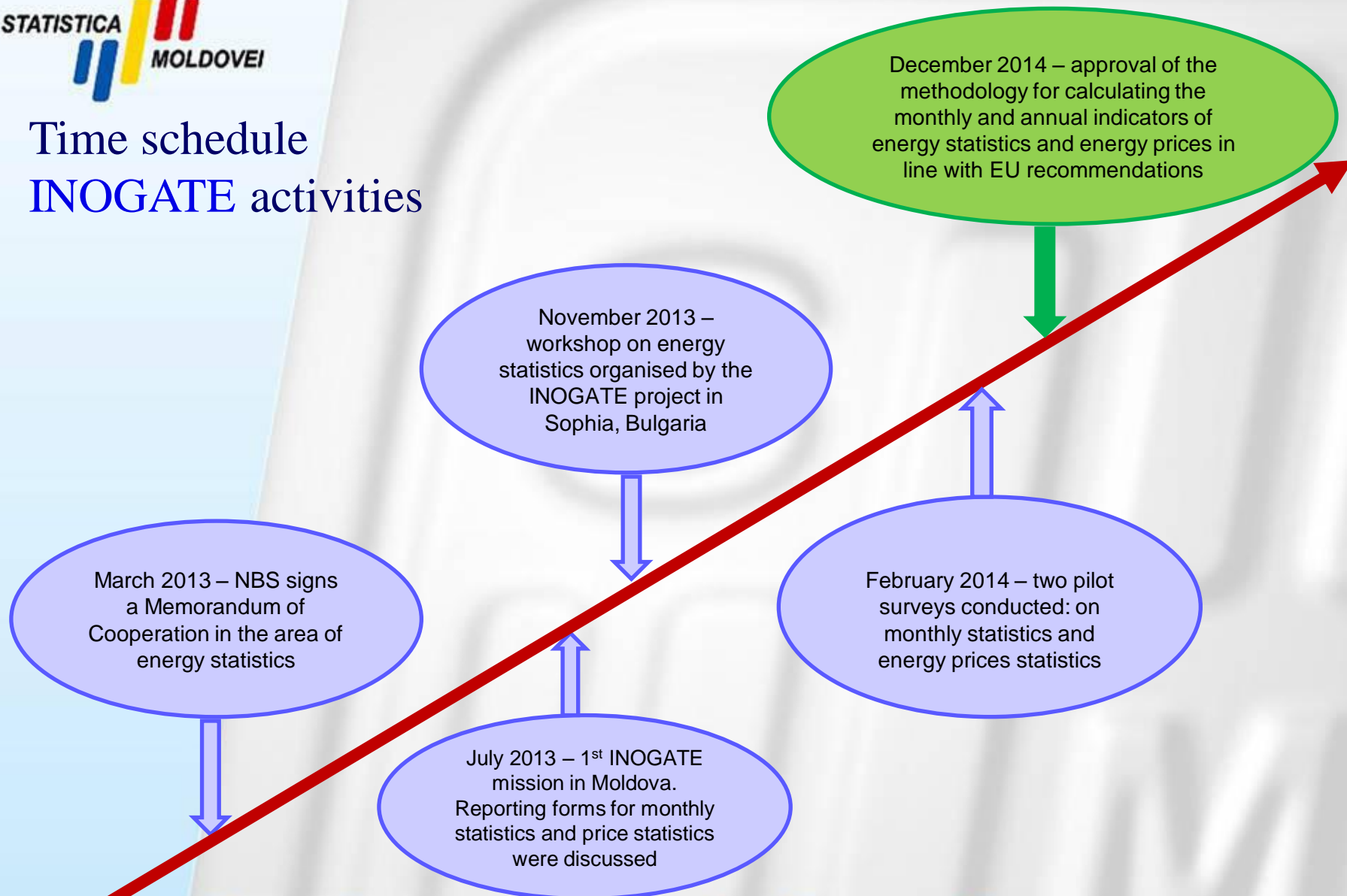
National Bureau of Statistics of the Republic of Moldova is the main body responsible for the collection, development and dissemination of official statistics in the Republic of Moldova.

March 2013 - a Memorandum on cooperation in the area of energy statistics signed between the National Bureau of Statistics, Ministry of Economy of the Republic of Moldova and the INOGATE Programme.

National Bureau of Statistics participated in all activities organised by INOGATE.

2010 - The Republic of Moldova becomes a full member of the Energy Community and undertakes a commitment to implement Regulation No 1099/2008 of the European Parliament and of the Council of 22.10.2008 on energy statistics and the Directive 2008/92/EC of the European Parliament and of the Council of 22.10.2008 concerning a Community procedure to improve the transparency of gas and electricity prices charged to industrial end-users.

Time schedule INOGATE activities



The methodological framework for the development of energy statistics:

- **Methodology for calculating the monthly and annual indicators of energy statistics and energy prices** approved by Order of the NBS Board. The methodology is based on the requirements of Regulation No 1099/2008 of the European Parliament and of the Council of 22.10.2008 on energy statistics and the Directive 2008/92/EC of the European Parliament and of the Council of 22.10.2008 concerning a Community procedure to improve the transparency of gas and electricity prices charged to industrial end-users.
- **International recommendations on energy statistics** of 2011, developed by the United Nations Statistics Division.

Key indicators calculated in the energy statistics:

- Monthly Statistics includes the following indicators :
 - Changes of primary stocks;
 - Supply of energy resources: production, import, export;
 - The consumption of key energy resources
- Price Statistics (once in six months):
 - Prices for natural gas and electricity for end-users in industry and construction;
 - Prices for natural gas and electricity for residential customers.

Dissemination of statistical information

- Publication of basic indicators on the web-site in the database
- International questionnaires (Jodi Gas, Jodi Oil)
- Submission of data to Eurostat through the single portal EDAMIS

The metadata on energy statistics is placed on the National Bureau of Statistics' web-site.
