### **Project: "INOGATE Technical Secretariat & Integrated Programme in support of the Baku Initiative and the Eastern Partnership energy objectives"**

The project is funded by the European Union in the framework of the INOGATE Programme ([www.inogate.org](http://www.inogate.org)). The regional project will be active in the beneficiary INOGATE Partner Countries – Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Tajikistan, Turkmenistan, Ukraine and Uzbekistan.

The project seeks to employ country experts on a part time basis till January 2015, starting in April 2012. The Country Expert will assist the INOGATE Secretariat in the implementation of the INOGATE related activities in the country and report on latest developments in the country in the energy field. He/She will also ensure the coordination and wide dissemination of information on INOGATE activities to the relevant INOGATE working group members and other stakeholders in the country in close coordination with the INOGATE Country Coordinator.

#### **Work description**

The role of the Country Expert is to be the focal point for the INOGATE Technical Secretariat and provide general support to the INOGATE institutional Framework. In particular, the Country Expert shall:

- Provide support to the INOGATE Secretariat and Country Coordinator for Kyrgyzstan
- Liaise closely with INOGATE Working Group Members and the nominated Regulatory Representative in Kyrgyzstan as well as the EU Delegation
- Report on a regular basis on new developments in the Energy Field in their country
- Contribute to the annual Status Report, Country Leaflets and a range of other media under the Communications activities of the ITS;
- Facilitate the Ad hoc expert Facility (AHEF) missions and clarify AHEF to national stakeholders
- Undertake initial screening of AHEF applications
- Provide assistance in the evaluation of the overall impact of AHEF support for dissemination to additional stakeholders within the country
- Provide logistic support in the coordination of events in the country.

- University degree in energy, engineering or other related fields
- Full working knowledge of English
- Knowledge of Russian and the local language is essential
